

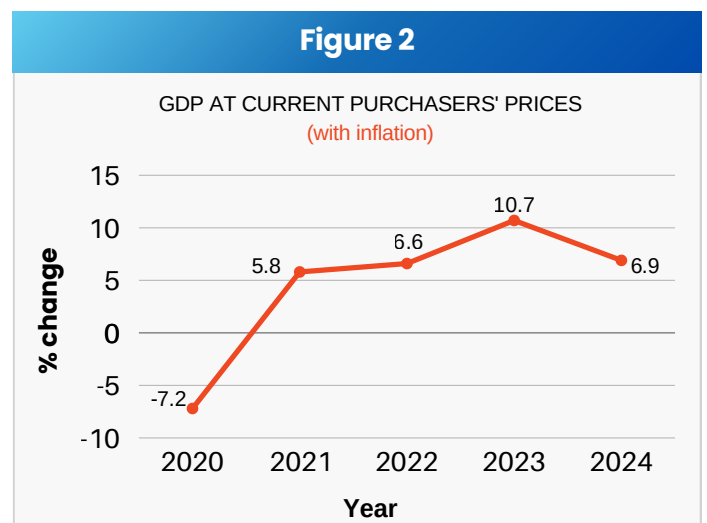
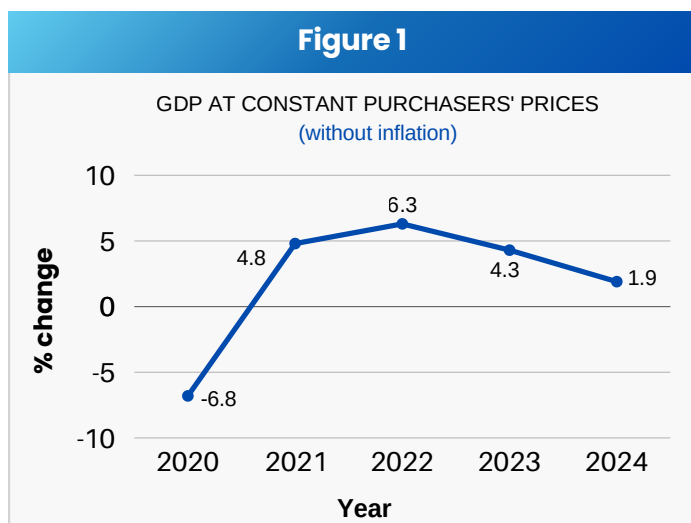

GDP At Constant Purchasers' Prices Increased 1.9 Per Cent In 2024

Gross Domestic Product (GDP) at constant purchasers' prices rose by 1.9 per cent to \$7.1 billion in 2024 (Figure 1; Table 1). Overall, 12 of the 19 industrial groups contributed positive growth to the real GDP. The largest increases to value added in absolute terms were recorded for International Business Activities, Information and Communication and Human Health and Social Work activities which grew by \$48.5 million, \$25.1 million and \$21.5 million, respectively. In contrast, value added in the Wholesale and Retail Trade industry, Financial and Insurance Activities, and Education industry decreased by \$10.5 million, \$10.1 million and \$3.9 million, respectively.

Economy-wide inflation, as measured by the implicit price index, was 4.9 per cent (Table 7). Including inflation, GDP at current purchasers' prices rose 6.9 per cent compared to 2023 (Figure 2; Table 4). GDP per capita at current prices was measured at \$143,878 (Table 4).



Cost Components, Institutional Sectors and National Accounts Aggregates

Compensation of Employees accounted for 56.6 per cent of the total cost of producing the GDP at current purchasers' prices in 2024 (Table 8). Operating Surplus/Mixed Income and Other Taxes less Subsidies (on production and products) represented 28.7 per cent and 8.0 per cent of the GDP at current purchasers' prices, respectively. Depreciation accounted for 3.2 per cent. In 2024, Non-Financial Corporations contributed 39.3 per cent of the total GDP at current purchasers' prices mostly concentrated in Real Estate activities, Professional, Scientific and Technical activities, and Wholesale and Retail Trade (Table 9). Financial Corporations contributed 40.6 per cent of total GDP at current purchasers' prices with General Government contributing 8.8 per cent and Households contributing 7.6 per cent.

Gross National Disposable Income (GNDI) amounted to \$9.3 billion at the end of 2024 (Table 10), up 7.7 per cent from 2023. After adjusting GNDI for consumption expenditure, Gross National Savings was measured at \$4.2 billion (Table 10) which represented a 12.5 per cent increase year-over-year. Of the total savings, \$1.0 billion was spent on gross capital formation (investment in capital goods). The Bermuda economy was a net lender to the rest of the world in the amount of \$3.2 billion, rising 15.0 per cent from 2023.

GDP YEAR-OVER-YEAR HIGHLIGHTS BY INDUSTRY—TABLES 1, 2 AND 3



Industry A – Agriculture, Forestry and Fishing

Value added for the Agriculture, Forestry and Fishing industry decreased 0.2 per cent in 2024 or \$22 thousand. The decrease in value added was attributed primarily to a fall in support activities to agriculture and post-harvest crop activities.



Industry C – Manufacturing

Activity for the Manufacturing industry fell 9.7 per cent or \$3.0 million. Manufacturing activities related to furniture experienced the largest percentage decrease in 2024.



Industries D&E* - Electricity, Water Supply and Waste Management

Value added for the Electricity, Water Supply and Waste Management industry decreased 1.3 per cent or \$1.2 million. This reflects lower value added in electricity, where rising input costs outpaced growth in output, partly offset by gains in water supply and waste management.



Industries F&B* – Construction and Quarrying

Value added for Construction and Quarrying activity increased 8.8 per cent or \$21.1 million. This was attributed to overall increases in activity related to construction projects.



Industry G – Wholesale and Retail Trade

Wholesale and Retail Trade recorded a decrease in value added of 3.4 per cent or \$10.5 million. Wholesale Trade activities decreased 3.7 per cent influenced mainly by wholesale of fuel and food, beverages and tobacco. Retail Trade activities decreased 4.4 per cent.



Industry H – Transportation and Storage

Value added for Transportation and Storage activities rose by 5.9 per cent or \$6.9 million in 2024 attributed mostly to increases in value added related to air transport and sea and coastal freight water transport.



Industry I – Accommodation and Food Service

Value added for Accommodation and Food Service activities was 0.3 per cent or \$0.7 million higher in 2024. This was influenced largely by an \$11.5 million growth in value added for accommodations, offset by contractions in Food Service activities.



Industry J – Information and Communication

Information and Communication services increased 16.4 per cent or \$25.1 million in 2024, driven mostly by a growth in telecommunications.



Industry K – Financial and Insurance Activities

Financial and Insurance Activities decreased 1.1 per cent or \$10.1 million. This fall was influenced predominantly by a 3.5 per cent decrease in financial service activities not related to insurance. The value added of trust companies and similar financial entities increased 1.0 per cent and Non-life insurance increased due to a rise in premiums.



Industry L – Real Estate Activities

Real Estate Activities rose 0.1 per cent or \$1.1 million as the imputed rent for owner-occupied dwellings grew 0.5 per cent and real estate activities with leased property decreased 0.4 per cent. There was a further 4.3 per cent contraction in real estate activities on a fee or contract basis.



Industry M - Professional, Scientific and Technical Activities

Value added for Professional, Scientific and Technical Activities was 3.5 per cent or \$13.7 million higher in 2024. The sub-industry groupings of advertising, accounting, bookkeeping and auditing activities, management consultancy, veterinary activities and legal activities experienced growth in value added. By contrast, there was a reduction in value added related to scientific research and development and architectural and engineering activities.



Industry N – Administrative and Support Services

Value added for Administrative and Support Services increased 12.3 per cent or \$16.8 million in 2024, influenced primarily by a rise in administrative and support services (+57.2 per cent), employment activities (+10.8 per cent), rental and leasing activities (+26.6 per cent) and cleaning activities (+14.9 per cent). This was offset by declines in security services (-2.1 per cent) and travel agency and tour operator services (-10.3 per cent).



Industry O – Public Administration

The value added for Public Administration declined by 0.6 per cent or \$2.0 million due mostly to lower expenditure on training and other personnel costs.



Industry P – Education

Value added for Education decreased 3.2 per cent or \$3.9 million in 2024 reflecting decreases in the contribution of private education.



Industry Q – Human Health and Social Work

Value added for Human Health and Social Work increased 6.3 per cent or \$21.5 million in 2024. Private health activities rose 17.5 per cent while public health activities rose 0.5 per cent. Social work activities also increased by 5.9 per cent.



Industry R – Arts, Entertainment and Recreation

Arts, Entertainment and Recreation activity rose by 1.7 per cent or \$0.5 million. Activities of libraries, archives, museums and historical sites and other recreational activities contributed to the increase in value added.



Industry S – Other Service Activities

Other Service Activities increased 4.0 per cent or \$2.8 million in 2024 attributed mostly to an increase in the value added of funeral and related activities, hairdressing and beauty treatment and personal care services.



Industry T – Activities of Households as Employers

Value added for Activities of Households as Employers rose 2.6 per cent or \$0.3 million.



Industry U – International Business Activity

Value added by International Business Activities rose 2.4 per cent or \$48.5 million in 2024. This industry was the largest contributor to GDP, representing 29.3 per cent of total GDP. Businesses engaged in reinsurance, insurance management and portfolio advisory experienced increases in value added. Conversely, businesses related to communication services activities and insurance brokerage services experienced declines in value added.

- ◆ **Base Year** – The starting point for the construction of an index number series. The base period or base year refers to the year in which an index number series begins to be calculated. This will usually have a starting value of 100.
- ◆ **Basic Price** - The amount receivable by the producer from the purchaser for a unit of a good or service produced as output minus any tax payable, and plus any subsidy receivable, on that unit as a consequence of its production or sale; it excludes any transport charges invoiced separately by the producer.
- ◆ **Financial Intermediation Services Indirectly Measured (FISIM)** - In the System of National Accounts it is an estimate of the value of the services provided by financial intermediaries, such as banks, for which no explicit charges are made; instead, these services are paid for as part of the margin between rates applied to savers and borrowers.
- ◆ **Gross Domestic Product (GDP)** - A measure of economic activity which captures the value of goods and services produced within a country during a given period. GDP can be expressed at current prices or constant prices.
- ◆ **Gross Domestic Product at Constant Prices (real GDP)** - Reflects the value of produced goods and services, but it uses constant consumer and producer price indices to remove the effects of rising price levels (inflation).
- ◆ **Gross Domestic Product at Current Prices (nominal GDP)** - Reflects the value of all the goods and services produced during a given period, using their price at the time of production.
- ◆ **Gross National Disposable Income (GNDI)** – The income available to the nation for gross savings and final consumption. It is calculated as GNI plus all current transfers in cash or in kind receivable by resident institutional units from non-resident units and subtracting all current transfers in cash or in kind payable by resident institutional units to non-resident units.
- ◆ **Gross National Income (GNI)** – The result of GDP plus income receivable from abroad from factors of production (e.g. compensation, property income and taxes) less income payable abroad.
- ◆ **Gross National Savings** – Comprises savings of households, businesses and government and is derived by subtracting final consumption expenditure from GNDI.
- ◆ **Gross Value Added (GVA)** - The value of output less the value of intermediate consumption; it is a measure of the contribution to GDP made by an individual producer, industry or sector.
- ◆ **Implicit Price Index (IPI)** – A price index for all final goods and services produced. It is calculated as the ratio of GDP in current prices to GDP in constant prices.
- ◆ **Intermediate Consumption** - A national accounts concept which measures the value of the goods and services consumed as inputs by a process of production. It excludes fixed assets whose consumption is recorded as consumption of fixed capital.
- ◆ **Purchaser's Price** - The amount paid by the purchaser, excluding any deductible value added tax or similar deductible tax; the purchaser's price of a good includes any transport charges paid separately by the purchaser to take delivery at the required time and place.
