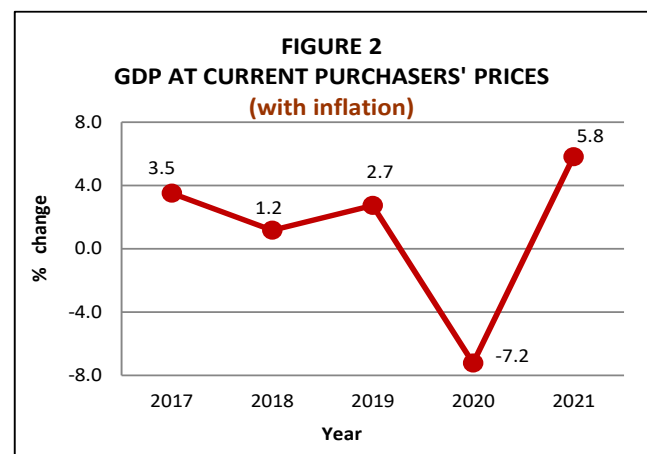
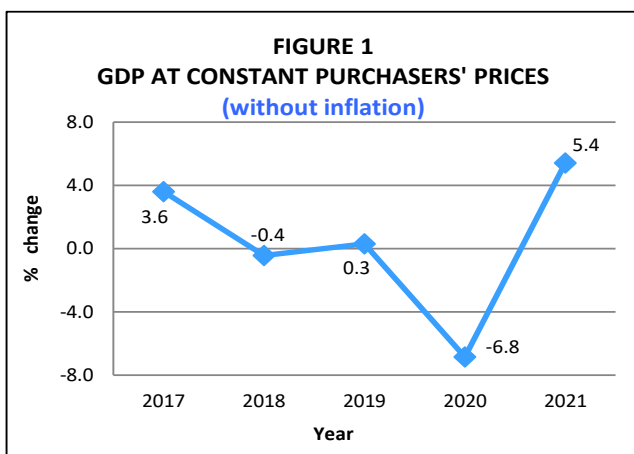




GDP At Constant Purchasers' Prices Increased 5.4 Per Cent In 2021

Gross Domestic Product (GDP) at constant purchasers' prices rose by 5.4 per cent to \$6.3 billion in 2021 (Figure 1; Table 1). This \$6.3 billion is still below pre-pandemic levels of \$6.5 billion in 2019. Overall, 14 of the 19 industrial groups contributed positive growth to the real GDP. The largest increases in absolute terms were recorded for International Business Activities, Accommodation and Food Services activities and Professional, Scientific and Technical activities which grew by \$138.5 million, \$63.0 million and \$45.2 million, respectively. In contrast, value added in the Public Administration industry fell \$10.5 million and the Construction and Quarrying industry decreased \$7.2 million.

Economy-wide inflation, as measured by the implicit price index, increased 0.4 per cent (Table 7). Including inflation, GDP at current purchasers' prices rose 5.8 per cent compared to 2020 (Figure 2; Table 4). GDP per capita at current prices was measured at \$113,755 (Table 4).



Cost Components, Institutional Sectors and National Accounts Aggregates

Compensation of Employees accounted for 70.1 per cent of the total cost of producing the GDP at current purchasers' prices in 2021 (Table 8). Operating Surplus/Mixed Income and other Taxes less Subsidies (on production and products) represented 13.7 per cent and 8.2 per cent of the GDP at current purchasers' prices, respectively. Depreciation accounted for 4.1 per cent. In 2021, non-financial corporations contributed 40.4 per cent of the total GDP at current basic prices mostly concentrated in Real Estate activities, Professional, Scientific and Technical activities, and Wholesale and Retail Trade (Table 9). Financial Corporations contributed 37.2 per cent of total GDP at current basic prices with General Government contributing 10.2 per cent and Households contributing 8.2 per cent. Gross National Disposable Income (GNDI) amounted to \$7.4 billion at the end of 2021 (Table 10), up 7.6 per cent from 2020. After adjusting GNDI for consumption expenditure, Gross National Savings was measured at \$3.1 billion (Table 10) which represented a 13.4 per cent increase year-over-year. Of the total savings, \$0.9 billion was spent on gross capital formation (investment in capital goods). The Bermuda economy was a net lender to the rest of the world in the amount of \$2.1 billion, rising 14.2 per cent from 2020.

GDP AT CONSTANT PURCHASERS' PRICES BY INDUSTRY—2021 HIGHLIGHTS

GDP Year-Over-Year Highlights by Industry (Constant Purchasers' Prices – Table 1, Table 2, Table 3)

Industry A – Agriculture, Forestry and Fishing

Value added for the Agriculture, Forestry and Fishing industry increased 24.8 per cent in 2021 or \$4.3 million. The increase in value added was attributed primarily to a rise in crop production and fishing activities.

Industry C – Manufacturing

Activity for the Manufacturing industry fell 6.3 per cent or \$1.7 million. Manufacturing activities related to bakery products and non-metallic mineral products experienced the largest decreases in 2021.

Industries D&E* - Electricity, Water Supply and Waste Management

Value added for the Electricity, Water Supply and Waste Management industry was \$9.3 million (+10.5 per cent) higher. This was due mostly to a rise in the contribution of electricity offset by a decrease in the value added of water supply.

Industries F&B* – Construction and Quarrying

Value added for Construction and Quarrying activity decreased 3.0 per cent or by \$7.2 million. This decline was attributed mostly to overall reduction in commercial construction projects.

Industry G – Wholesale and Retail Trade

Wholesale and Retail Trade recorded a decrease in value added of 1.0 per cent or \$3.2 million. Retail Trade activities decreased 6.3 per cent influenced primarily by lower sales of food, clothing and building materials and was offset by increases in sales of fuel. Wholesale Trade activities increased 14.7 per cent influenced mainly by wholesale of fuel and food, beverages and tobacco.

Industry H – Transportation and Storage

Value added for Transportation and Storage activities grew by 5.1 per cent or \$5.2 million in 2021 attributed mostly to increases in value added related to passenger land transport and courier activities for air transportation.

Industry I – Accommodation and Food Service

Value added for Accommodation and Food Service activities was 86.1 per cent or \$63.0 million higher in 2021. Value added for hotels increased by \$61.3 million due to a rise in visitor arrivals and hotel occupancy. Food service activities fell \$1.7 million (+2.8 per cent).

GDP AT CONSTANT PURCHASERS' PRICES BY INDUSTRY—2021 HIGHLIGHTS

Industry J – Information and Communication

Information and Communication services increased 1.2 per cent or \$1.8 million in 2021 driven mostly by a rise in publishing services (+17.3 per cent) and telecommunication (+1.2 per cent) .

Industry K – Financial and Insurance Activities

Financial and Insurance Activities decreased 0.1 per cent or \$0.8 million. This decline was attributed primarily to the activities of the commercial banking sector which fell 5.5 per cent reporting less net interest income. The value added of trust companies and similar financial entities increased 13.9 per cent. Non-life insurance increased due to a 7.2 per cent rise in premiums.

Industry L – Real Estate Activities

Real Estate Activities rose 3.2 per cent or \$31.0 million. There was also a 2.8 per cent rise in the imputed rent for owner-occupied dwellings, as well as a 2.1 per cent increase in real estate activities with leased property. The increase was reflected mostly in a 30.7 per cent rise in real estate activities on a fee or contract basis.

Industry M – Professional, Scientific and Technical Activities

Value added for Professional, Scientific and Technical Activities was 14.5 per cent or \$45.2 million higher in 2021. The sub-industry groupings of accounting services, legal services and professional services experienced the largest increases in value added.

Industry N – Administrative and Support Services

Value added for Administrative and Support Services increased 17.2 per cent or \$18.6 million in 2021 influenced primarily by a rise in administrative and support services (+47.8 per cent), facilities support activities (+24.4 per cent), security services (+15.6 per cent) and landscaping activities (+14.9 per cent). This was offset by declines in rental and leasing activities (-17.3 per cent) and travel agency and tour operator services (-1.4 per cent).

Industry O – Public Administration

The value added for Public Administration declined by 3.4 per cent or \$10.5 million due mostly to a fall in compensation and lower expenditure on professional services.

Industry P – Education

Value added for Education increased 0.1 per cent or \$0.1 million in 2021 reflecting a return to normal business function of schools that were temporarily closed as part of government restrictions to control the spread of the coronavirus.

Industry Q – Human Health and Social Work

Value added for Human Health and Social Work increased 6.4 per cent or \$20.6 million in 2021. Private health activities grew 13.1 per cent while public health activities fell 2.1 per cent. Social work activities recorded a 45.7 per cent increase due mostly to residential care activities for the elderly and disabled.

Industry R – Arts, Entertainment and Recreation

Arts, Entertainment and Recreation activity grew by 17.8 per cent or \$3.7 million. Sporting and recreational activities contributed positively to the rise in value added for this industry while the activities of museums and historical sites and other recreational activities showed continued declines in activity.

Industry S – Other Service Activities

Other Service Activities increased 26.6 per cent or \$13.4 million in 2021 attributed mostly to an increase in the value added of membership organisations, hair dressing and beauty treatment, funeral and related services and personal care services.

Industry T – Activities of Households as Employers

Value added for Activities of Households as Employers grew by 15.8 per cent or \$1.8 million.

Industry U – International Business Activity

Value added by International Business Activities rose 8.4 per cent or \$138.5 million in 2021. This industry was the largest contributor to GDP, representing 28.1 per cent of total GDP. Businesses engaged in reinsurance, portfolio management services and insurance brokerage services experienced the largest increases in value added. Conversely, communication activities experienced a 51.4 per cent decline in value added.

GROSS DOMESTIC PRODUCT—DEFINITIONS

Base Year – The starting point for the construction of an index number series. The base period or base year refers to the year in which an index number series begins to be calculated. This will usually have a starting value of 100.

Basic Price - The amount receivable by the producer from the purchaser for a unit of a good or service produced as output minus any tax payable, and plus any subsidy receivable, on that unit as a consequence of its production or sale; it excludes any transport charges invoiced separately by the producer.

Financial Intermediation Services Indirectly Measured (FISIM) - In the System of National Accounts it is an estimate of the value of the services provided by financial intermediaries, such as banks, for which no explicit charges are made; instead these services are paid for as part of the margin between rates applied to savers and borrowers.

Gross Domestic Product (GDP) - A measure of economic activity which captures the value of goods and services produced within a country during a given period. GDP can be expressed at current prices or constant prices.

Gross Domestic Product at constant prices - Reflects the value of produced goods and services, but it uses constant consumer and producer price indices to remove the effects of rising price levels (inflation).

Gross Domestic Product at current prices - Reflects the value of all the goods and services produced during a given period, using their price at the time of production.

Gross National Disposable Income (GNDI) – The income available to the nation for gross savings and final consumption. It is calculated as GNI plus all current transfers in cash or in kind receivable by resident institutional units from non-resident units and subtracting all current transfers in cash or in kind payable by resident institutional units to non-resident units.

Gross National Income (GNI) – The result of GDP plus income receivable from abroad from factors of production (e.g. compensation, property income and taxes) less income payable abroad.

Gross National Savings – Comprises savings of households, businesses and government and is derived by subtracting final consumption expenditure from GNDI.

Gross Value Added (GVA) - The value of output less the value of intermediate consumption; it is a measure of the contribution to GDP made by an individual producer, industry or sector.

Implicit Price Index (IPI) – A price index for all final goods and services produced. It is calculated as the ratio of GDP in current prices to GDP in constant prices.

Intermediate Consumption - A national accounts concept which measures the value of the goods and services consumed as inputs by a process of production. It excludes fixed assets whose consumption is recorded as consumption of fixed capital.

Purchasers' Price - The amount paid by the purchaser, excluding any deductible value added tax or similar deductible tax; the purchaser's price of a good includes any transport charges paid separately by the purchaser to take delivery at the required time and place.
