  - <u>www.gov.bm</u> hosted on AWS in Ireland. PHP/Drupal-based LAMP-stack system managed/supported by 3<sup>rd</sup>party
  - forms.gov.bm hosted on prem and is .Net. This is where our applications are developed primarily in-house

- Most FQDNs forward to a page on gov.bm. URLs are: www.gov.bm/path-name1/path-name-2 or forms.gov.bm/path-name1/path-name-2

- officialgazette.gov.bm - forwards to www.gov.bm/official-gazette.

- Q10. For the resistance evaluation is there a requirement to execute DoS/resilience tests? If yes, what are they?

- Q11. All tests are to be runned over exposed assets and should be conducted remotely?

- Q12. Is there any requirement to execute evaluation or assessment over assets that are not exposed?
