The following addendum supersedes information contained in the solicitation document issued for this procurement to the extent referenced. This Addendum forms part of the solicitation documents and will be subject to all the conditions set out in the contract conditions.

- 1. The Submission Deadline is extended to April 5, 2024, 3:00 PM Local Time.
- 2. Annex B -Pricing Form is amended to include an additional line item for the lump sum repairs to the saddles (which are the metal support at the tops of the columns with the timber beams). In addition, the breakdown between the railings and beams has been amended to allow individual line items for preliminaries, and overheads and profit. Revised Annex B is attached.
- **Q1.** Is the porch slab capable of supporting the scaffolding/jacks that will be used to temporarily support the balcony slab during the beam replacement without supports to the grade below the porch?
- **A1.** The contractor shall provide and maintain for duration of work all required temporary standing scaffolding and 'Independent tied' scaffold and all necessary temporary supports/props including to the upper and lower floor slabs as necessary.
