**CONTRIBUTORY PENSIONS (AMENDMENT OF CONTRIBUTIONS AND  
BENEFITS) ORDER 2025**

The Minister of Finance, in exercise of the power conferred by section 37 of the Contributory Pensions Act 1970, makes the following Order:

**Citation**

1 This Order, which amends the Contributory Pensions Act 1970 (the “principal Act”), may be cited as the Contributory Pensions (Amendment of Contributions and Benefits) Order 2025.

**Amends principal Act to increase benefits**

2 The benefit rates in the provisions of the principal Act referred to in column 1 of Schedule 1 to this Order are repealed and replaced by the amounts set out in column 2 of that Schedule.

**Amends principal Act to increase contributions**

3 The contribution rates in the provisions of the First Schedule to the principal Act referred to in column 1 of Schedule 2 to this Order are repealed and replaced by the amounts set out in column 2 of that Schedule.

**Commencement**

- 4 (1) Paragraph 2 of this Order comes into effect on 16 August 2025.  
(2) Paragraph 3 of this Order comes into effect on 1 August 2025.
