







Global House First Floor, Office Cleaning 2021: All Areas to be Included for Cleaning




Global House Fourth Floor, Office Cleaning 2021: All Areas to be Included for Cleaning




Global House Ground Floor, Office Cleaning 2021: All Areas to be Included for Cleaning




