Professional Services to include (but not limited to) the following:

# 1. Electrical Design

- a. Survey existing conditions
- Design electrical power distribution, lighting, fire alarm system (life safety devices), security system (panic hardware, CCTV Cameras, Card/Proxy Readers) to suit the new layout
- c. Coordinate data/communications system rough-in requirements with the Government's IDT Department

## 2. Mechanical Design

- b. Design Heating, Ventilation, & HVAC to suit the new layout
- c. Provide design calculations
