## CIRCULAR NO.7 OF 2023

## **TO ALL ATTORNEYS**

## **RE: AMENDMENTS TO COURT FEES (SUPREME COURT AND COURT OF APPEAL)**

As you are aware, the Registrar is presently in consultation with the Government of Bermuda to amend the Rules of the Supreme Court 1985, the Civil Appeal Rules 1971 (Second Schedule) and the Rules of the Court of Appeal 1965. The amendments will bring <u>increases</u> to the Courts' current fee structure for actions commenced in the Supreme Court and the Court of Appeal.

The amended fee schedule will also bring changes to the categories of fees, with <u>a separate fee</u> <u>structure introduced for commercial actions</u>. Commercial Actions are defined at Order 72, Rule 1 of the Rules of the Supreme Court 1985, as set out below. Order 72, Rule 1 of the Supreme Court Act 1985 will remain unchanged.

## ORDER 72

## **COMMERCIAL ACTIONS**

## 72/1 Application and Interpretation

1 (1) This Order applies to commercial actions in the Supreme Court, and the other provisions of these Rules apply to those actions subject to the provisions of this Order.

(2) In this Order "commercial action" means any claim or counterclaim arising out of the transaction of trade and commerce and—

- (a) includes any claim or counterclaim relating to-
  - (i) a business document or contract;
  - (ii) the export or import of goods;
  - (iii) the carriage of goods by land, sea, air or pipeline;
  - (iv) the exploitation of oil and gas reserves or other natural resources;
  - (v) insurance and re-insurance;
  - (vi) banking and financial services;
  - (vii) the operation of markets and exchanges;
  - (viii) the purchase and sale of commodities;
  - (ix) the construction of ships;
  - (x) business agency; and
  - (xi) arbitration.
- (b) includes any application under the Companies Act 1981.

(3) There is hereby constituted, as part of the Supreme Court, a Commercial Court to take such causes and matters as may in accordance with this Order be entered in the commercial list.

It is widely known that Bermuda's current fee structure is manifestly low, especially when compared to other British Overseas Territories. The increased fees will ensure that Bermuda's Court Fees are aligned with those similar jurisdictions. Additionally, as it relates to the fees payable in commercial cases in particular, the increased fees will be reflective of the increased judicial resources that are required to deal with those cases on a timely basis.

It is anticipated that the amendments will come into effect on **1 April 2023**. Therefore, documents filed into the Registry of the Supreme Court and the Court of Appeal on or after<u>3</u> <u>April 2023</u> will be subject to the updated fee schedule.

Draft copies of the proposed amendment rules are attached to this Circular, and include:

- 1. Draft Rules of the Supreme Court Amendment Rules 2023;
- 2. Draft Civil Appeal Amendment Rules 2023; and
- 3. *Draft* Rules of the Court of Appeal for Bermuda Amendment Rules 2023.

While these amendment rules remain to date in draft form, it is anticipated that the fee schedules provided will be those that are put into effect on the abovementioned dates.

Please be advised the Court Fees payable in the Supreme Court and the Court of Appeal can be made in the usual manner by Revenue Stamps, Cheque, or Bank Draft with effect from 3 April 2023. Additional forms of payment will hopefully become available in the near future.

The Chief Justice, in exercise of the power conferred by section 62 of the Supreme Court Act 1905, makes the following Rules:

#### Citation

1 These Rules may be cited as the Rules of the Supreme Court Amendment Rules 2023.

#### Amends order 62

2 Order 62 of the Rules of the Supreme Court 1985 is amended by inserting after rule 34 the following—

#### "62/35 Scales of costs

The President, in exercise of the power conferred by section 9 of the Court of Appeal Act 1964, makes the following Rules:

#### Citation

1 These Rules may be cited as the Rules of the Court of Appeal for Bermuda Amendment Rules 2023.

#### Amends the Third Schedule

2 The Third Schedule of the Rules of the Court of Appeal for Bermuda is revoked and replaced by the contents of the Schedule to this Act.

#### **Amends Fourth Schedule**

3 The Fourth Schedule of the Rules of the Court of Appeal for Bermuda is amended as follows—

(a) in Scale A, by revoking and replacing the first paragraph with—

"Unless otherwise specified, costs payable to attorneys shall be taxed at the rate of \$250 to \$350 per hour or any fraction thereof (hereinafter call the "Hourly rate").";
