ABANDONED VESSEL NOTICE

Marine & Ports Authority (Dumping) Regulations 1967

TAKE NOTICE THAT pursuant to the *Marine & Ports Authority (Dumping) Regulations 1967* (“the Regulations”), the Minister of Transport may direct the disposal of any vessel which has been abandoned and is likely to become unsightly or prejudicial to the free navigation of the territorial waters of Bermuda. In doing so, the Minister may direct that the person responsible for the abandonment of the vessel be liable for the costs associated with the disposal of the vessel.

The vessel listed below has been identified as an abandoned vessel subject to disposal. However, before any action is taken with respect to the vessel, you as the identified owner have **30** days from the date of receipt of this Notice to take the appropriate action to remove your vessel from its current location and relocate it to a site which does not contravene the provisions of the *Merchant Shipping Act 2002*, the *Marine Board Act 1962*, the *Regulations* or any other law of Bermuda.
