 - The Compliance Officer;
 - The Reporting Officer; and
 - o All Brokers & Agents.

If more space is needed the answers should be typed in the space provided at the back of this questionnaire headed "Additional Information" and clearly identify the question to which the details relate. The form should be completed and signed electronically, using Adobe.

APPENDIX I

DEFINITIONS: THE MEANINGS OF "DIRECTOR", "CONTROLLER" AND "SENIOR EXECUTIVE" are defined in section 11B of the Proceeds of Crime (Anti-Money Laundering and Anti-Terrorist Financing Supervision and Enforcement) Act 2008 and Schedule 1 of the Real Estate Brokers' Licensing Act 2017.

- 1. "Director" in relation to a real estate business, includes any person who occupies the position of director, by whatever name called.
- 2. "Controller" in relation to a real estate business, means-
 - (a) in the case of a regulated DIHVG which is a company, a managing director of the company, or of its parent entity;
 - (b) in the case of a real estate business which is a firm-
 - (i) if a partnership, the managing partner; or
 - (ii) if an unincorporated association, a member of the firm;
 - (c) in the case of a real estate business which is neither a company nor a firm, a sole proprietor;
 - (d) a chief executive of a real estate business or of its parent entity; and
 - (e) a person who-
 - (i) holds ten percent or more of the shares in a real estate business which is a company, or in its parent entity;
 - (ii) is entitled to exercise or control the exercise of ten percent or more of the voting power in the real estate business or in the parent entity; or
 - (iii) is able to exercise a significant influence over the management of the real estate business or the parent entity by virtue of the voting power in the real estate business or the parent entity; and
 - (f) a person in accordance with whose directions or instructions the following persons are accustomed to act—

 (i) the directors of the real estate business;
 - (ii) the directors of the parent entity of the real estate business; and
 - (iii) persons who are controllers by virtue of paragraph (e).
- 3. "Senior executive", in relation to a real estate business, means a person who, under the immediate authority of a director or chief executive of the real estate business
 - (a) exercises managerial functions; or
 - (b) is responsible for maintaining accounts or other records of the real estate business.
