All works associated with the demolition of the King's Wharf concrete deck. The existing piles are to remain and be reused. The piles will be at their most vulnerable during the demolition phase and measures to protect them from moving or becoming damaged is the responsibility of the contractor. Prior to demolition the utilities connected to the deck must be disconnected for reuse. Demolition work must be done in accordance with an approved work and safety method statement. #### **Demolition of existing King's Wharf Concrete Deck**

The existing King's Wharf concrete deck is founded on several steel H piles that must be maintained for reuse. There are existing water and sewage services that supply the cruise ships and the terminal building. The water and sewage services attached to the deck must be disconnected, removed and stored/replaced in preparation for use with the new concrete deck.

## **Demolition of existing King's Wharf Concrete Deck**

The existing King's Wharf concrete deck is founded on several steel H piles that must be maintained for reuse. The piles will be susceptible to movement during demolition, use of preventative measures to brace the piles from moving is advised.

There are existing water and sewage services that supply the cruise ships and the terminal building. The water and sewage services attached to the deck must be disconnected, removed and stored/replaced in preparation for use with the new concrete deck.

In addition the concrete debris remaining from the partial stripping of the concrete piles is to be removed from the seabed and disposed of along with the deck concrete. The concrete pieces must be properly disposed of at the WEDco designated site with in Dockyard. No debris is to be left on the seabed and underwater inspection of the seabed will be conducted before and after construction.
