When submitting an application form, please attach the following:

- A copy of a certified Certificate of Ordination or a written confirmation of the applicant's qualifications from a senior administrative authority of the applicant's religion.
- A copy of formal Identification
- Payment in the amount of \$105.00 (**non-refundable**) - credit card, bank draft, wire payment

An application to be a Marriage Officer shall be made in writing, in the first instance, to the Registrar General either by the Minister himself or by the Senior Minister of the Christian body to which the Minister belongs.

A Minister wishing to come to Bermuda to perform a marriage ceremony must be a Minister of either a Christian Religion, the Jewish Religion, the Baha'i Religion or the Muslim Religion. A Jewish Rabbi is licenced under the provisions of the above-mentioned Act in conjunction with The Jewish Marriage Act, 1946. In this instance "Rabbi" means a priest or other person of the Jewish faith who is authorized by or under the rules and usages of that faith to celebrate marriages according to its rites and ceremonies.

Once an application is approved, the Registry General will contact the applicant regarding collection of the licence and other relevant materials.
