

# **PROCUREMENT NOTICE**

This Procurement Notice is issued by the Government of Bermuda (the "Government") to provide summary information in relation to a specific procurement, as detailed below.

# 1. Subject Matter of Procurement

## RFX Title: Independent Clinical Waste Incinerator Exhaust Analysis and Assessment

#### RFX Number: RFQDENR2023-1

#### Purchase Type: Service

The Department of Environment & Natural Resources seeks an environmental monitoring company to provide independent analytical monitoring of gaseous-based contaminants in the exhaust of a clinical waste incinerator over a period of 3-months with assessment and reporting of the results. The clinical waste incinerator is based in Southside and has been provided with a construction permit and operating licence by the Environmental Authority under the Clean Air Act 1991.

The successful respondent will need to measure the various contaminants in the gaseous portion of the exhaust and compare these results to:

- 1. The limits provided in the Industrial Emissions Directive (IED) for Small Waste Incineration Plants (SWIP) as regulated under the UK Environmental Permitting Regulations (EPR),
- 2. The emission rates used in the air dispersion modelling for this facility, and
- 3. The contaminant data for gaseous-based pollutants that will also be measured by the owner/operator of the facility, MediWaste (Bermuda) Triad Ltd.

# ADDITIONAL INFORMATION

Good day,

Government is looking for a company to provide independent clinical waste incinerator exhaust analysis:

- To a controlled facility located on Waller's Point Road, St David's.
- Using certified sensors capable of measuring a range of gases/vapours in the exhaust for 3-days per week over a 3-month period.
- Data collected will need to be converted to standard temperature and pressure and to a standard oxygen concentration.
- Comparison of the data collected to: (i) UK standards, (ii) Emission rates used in recent air dispersion modelling to Bermuda's Clean Air Regulations 1993, and (iii) Data being collected concurrently by the owner/operator of this licenced facility.
- Monthly progress reports and a final report are required upon completion to the details provided in the RFQ.

Please note that all respondents will be offered an opportunity to attend a pre-bid meeting and to also attend the site in St David's to see the Clinical Waste Incinerator on Friday 11th August or within an agreed date/time close to this date.

Dr Geoff Smith will require 5 days' notice to coordinate the site visit. The RFQ submission deadline is Friday 8th September.
