

PROCUREMENT NOTICE

This Procurement Notice is issued by the Government of Bermuda (the "Government") to provide summary information in relation to a specific procurement, as detailed below.

1. Subject Matter of Procurement

RFX Title: Specified Goods and Services

RFX Number: 2022-006Q-MPW

Purchase Type: Goods

This Request for Supplier Qualifications ("RFSQ") is an invitation by the Government of Bermuda (the "Government") to prospective respondents to qualify in accordance with Evaluation of Responses (Part 2) for eligibility to provide goods and services under this Vendor Prequalification Program as further described in Section A of the RFSQ Particulars (Appendix B) (the "Deliverables").

The Ministry of Public Works [MPW] seeks to generate a list of prequalified Contractors who are interested in providing goods and services for the Government's 2023-2024 fiscal year.

This Open-Ended invitation allows MPW to prequalify contractors from February 1, 2023, until March 31, 2024. There are four intake periods for this program as stated in the Key Dates Section 1.4.1. During this time, contractors may be added to the lists if they pass the pre-qualification process. To stay on the Approved Contractor List (ACL), the Contractor must submit an updated statement of qualification for evaluation no later than 12 months after the Contractor was added to the list as an Approved Contractor. There are four submission deadlines to ensure that contractors can be added throughout the year. After an open-ended approved contractor list is initially established, other Contractor who wishes to be added to that list must submit statements of qualifications according to the schedule stated in the RFSQ. Such statements will be evaluated as provided, and contractors meeting the minimum mandatory requirements, evaluation criteria,

and applicable score thresholds of the original request (and whose statement is not rejected according to the outline process) will be added to the list.

The MPW shall keep the RFSQ associated with an open-ended approved contractor list posted and available on the Government Portal website throughout the period that the list is effective.

This program will use prequalified companies that be selected through this RFSQ process [1] to provide maintenance, repair and/ or improvement to existing infrastructure; [2] construct new assets and infrastructure; or [3] provide goods and services as described in Section A of the RFSQ Particulars (Appendix B) (the "Deliverables").

To this end, MPW Departments and Sections have compiled a list of specified goods and services that may be required during the Government's fiscal year 2023-2024.

In addition to identifying local contractors and service providers, the prequalification process will allow the Government to match expertise and capacity to the scope of work included in each project or service required. The criteria for prequalification will consist of scoring technical competence and local benefits.

Pre-qualified and ranked Contractor may then be invited to participate in a second stage, a fast-track tender process for each of the services/projects.
