WINTER OPENING HOURS OF THE SUPREME COURT REGISTRIES

Friday the 23rd December 2016

- 1. On Friday the 23rd December 2016, the Registry Office located at the Government Administration Building and the Registry Office located at the Dame Lois Browne Evans Building will be closing at 3 p.m.
- 2. This Direction does not affect cases already set down for a hearing.

Wednesday the 28th December to Friday the 30th December 2016

The following early closures of the various Registry locations for the period of the 28th December to the 30th December 2016 has been undertaken to allow for Registry staff to focus their efforts on the final relocations tasks. Members of the public and members of the Bar are thanked for their continued patience.

A. GOVERNMENT ADMINISTRATION BUILDING ("GAB")

- 4. From the 28th December 2016 to the 30th December 2016, the Registry located at GAB will close to the public at 1:00 p.m. each day. As has been done for previous winter closings, attorneys <u>must</u> arrange to file documents in the Registry between 8:30 a.m. and 1:00 p.m.
- 5. This Direction does not affect cases already set down.
- 6. If there are urgent filings, arrangements may be made to have them accepted between 2:30 p.m. and 4:30 p.m. by contacting the Registrar by email.

7. As a reminder, as set out in Circular No 25 of 2016, the Registry located on the second floor of GAB will accept the following filings:

- (a) All filings related to Court of Appeal proceedings, including leave to appeal proceedings;
- (b) All commercial and civil filings (save for civil proceedings under the Minors Act 1950 or Children's Act);
- (c) All filings related to appeals from the Magistrates' Court;
- (d) All filings related to Call to the Bar applications, notary applications and registered associates applications; and
- (e) All Search Praecipes in relation to civil files.

B. DAME LOIS BROWNE EVANS BUILDING ("DLBE BUILDING")

Supreme Court

- 8. From the 28th December 2016 to the 30th December 2016, the Registry located at DLBE will close to the public at 1:00 p.m. each day. As has been done for previous winter closings, attorneys <u>must</u> arrange to file documents in the Registry between 8:30 a.m. and 1:00 p.m.

 - (a) All filings related to the criminal proceedings;
 - (b) All filings related to the Supreme Court matrimonial or family proceedings including civil filings under the Minors Act 1950 and the Children's Act;
 - (c) All filings related to probate and estate should take place on the third floor reception of DLBE Building; and
 - (d) All Search Praecipes in relation to matrimonial, family, criminal and probate files.

Magistrates' Court

- 15. This Direction does not affect cases already set down for a hearing.
