It is the responsibility of the proponents to determine which partner will act as the prime contractor. As noted in the RFP, joint submissions are acceptable, however if a joint submission is made, the submission must clearly indicate which party will act as the prime contractor. <u>Please note that in this case there</u> was a Mandatory Pre-Bid Meeting. <u>The proposal would be considered as</u> long as a representative of the Joint <u>Venture was present (regardless if it</u> is the prime contractor or not).
2	RFP APPENDIX C - PRICING		Import Duties	Could you confirm whether or not, imported materials would be exempt from import duty?	Imported materials would <u>not</u> be exempt from import duty.
3	RFP Drawing S-2	C	Expansion Joints	Please note that the specified asphaltic plug joints are not capable of taking the movement prescribed at the East Side of the bridge (+/- 28mm). Plug joints will also be only just capable of taking the movement to the West Side (+/- 19mm). Can we quote alternative joints which will be capable of handling the expected movements?	Yes. As stated on Drawing S-2, the Ministry of Public Works will consider any option that does not require mechanical fixings to the concrete deck and that is capable of accommodating the specified movements.
